As of December 31, 2023, (i) 704,383 shares of Class A common stock held of record by The Jack Dorsey 2023 Annuity Trust U/A/D May 26, 2023, (ii) 295,617 shares of Class A common stock held of record by The Jack Dorsey 2022 Annuity Trust U/A/D May 27, 2022, (iii) 35,763,992 shares of Class B common stock held of record by the Jack Dorsey Revocable Trust U/A/D 12/8/10, for which Mr. Dorsey serves as Trustee, and (iv) 12,080,574 shares of Class B common stock held of record by Start Small, LLC, of which Mr. Dorsey is the sole member.

Each share of Class B Common Stock is convertible into one share of Class A Common Stock at the option of the holder and has no expiration date. Each share of Class B Common Stock is entitled to ten votes per share, whereas each share of Class A Common Stock is entitled to one vote per share. The rights of the holders of Class A Common Stock and Class B Common Stock are identical, except with respect to the aforementioned conversion rights and voting rights.

The ownership percentage above is calculated based on 555,498,864 shares of Class A Common Stock outstanding as of December 31, 2023, as reported by the Issuer to the Reporting Person, which includes 295,617 shares of Class A Common Stock held of record by The Jack Dorsey 2022 Annuity Trust and 704,383 shares of Class A Common Stock held of record by The Jack Dorsey 2023 Annuity Trust, plus the assumed conversion of 47,844,566 shares of Class B Common Stock deemed beneficially owned by Mr. Dorsey, as described herein, into shares of Class A Common Stock.
