The Application-Declaration is amended as follows:

Item 5. Procedure

Item 5, Procedure, is hereby amended in its entirety and restated to read as follows:

The parties request that the Commission's notice of proposed transactions published pursuant to Rule 23(e) be issued by June 6, 1996, or as soon thereafter as practicable, and that the Commission's order authorizing the remaining transactions proposed in this proceeding be issued by July 12, 1996, or as soon thereafter as practicable.

The parties hereby waive a recommended decision by a hearing officer or any other responsible officer of the Commission; agree that the Staff of the Division of Investment

Management may assist in the preparation of the Commission's decision, and request that there be no waiting period between the issuance of the Commission's order and the date it is to become effective.

The Company requests that the Commission's order authorizing the above transactions release reservations of jurisdiction over (i) the execution of and performance under any Reimbursement Agreement underlying any letter of credit issued as security for the Company's obligations in connection with the issuance and sale of Tax-Exempt Bonds and (ii) the proposed issuance and sale of Debentures, in each case pending completion of the records with respect thereto.
