Litigation

On January 3, 1995, plaintiffs in the shareholder derivative action, Alan R. Kahn and The Tudor Trust v. Herbert Haft, et al., C.A. No. 13154 (Del. Chancery), filed a motion for the appointment of a temporary custodian to manage the affairs of Dart Group Corporation (the "Corporation") or of a receiver to sell it or oversee a recapitalization thereof. The Corporation intends to oppose this motion.
