Section 4 – Matters Related to Accountants and Financial Statements

Item 4.01 Changes in Registrant's Certifying Accountant

(a) On March 1, 2013 sent a letter to Hood & Associates, CPAs, P.C. in which they confirmed the termination of the client-auditor relationship.

There were no disagreements (as defined in Item 304 of Regulation S-K) with Hood & Associates on any matter of accounting principles or practices, financial statement disclosure, or auditing scope or procedure, which disagreements, if not resolved to the satisfaction of Hood & Associates, would have caused it to make reference in connection with its opinion to the subject matter of the disagreement. The report of Hood & Associates did state that there was substantial doubt about the Company's ability to continue as a going concern.

We provided Hood & Associates with a copy of the above disclosures and requested that Hood & Associates provide us with a letter addressed to the Securities and Exchange Commission stating whether it agrees with such disclosures.

(b) *Engagement of new independent registered public accounting firm.*

On March 1, 2013 our Board of Directors engaged MaloneBailey LLP, as its independent registered public accounting firm.

During the Company's most recent fiscal year end and the interim periods preceding the engagement of MaloneBailey LLP, and through March 1, 2013 neither the Company nor anyone acting on our behalf, has consulted with MaloneBailey LLP regarding either: (i) the application of accounting principles to a specified transaction, either contemplated or proposed, (ii) the type of audit opinion that might be rendered on the Company's financial statements, or (iii) any matter that was either the subject of a disagreement between the Company and Hood & CO.as described in Item 304(a)(1)(iv) of Regulation S-K or a reportable event as described in Item 304(a)(1)(v) of Regulation S-K.
