In accordance with the provisions of Rule 24f-2 under the Investment Company Act of 1940, Merrill Lynch International Holdings, Inc. d/b/a Merrill Lynch Global Holdings (the "Fund") hereby files its Rule 24f-2 Notice (the "Notice").

1. The Notice is being filed for the fiscal year of the Fund ended November 30, 1993 (the "Fiscal Year").
2. 10,666,462 shares of common stock of the Fund which had been registered under the Securities Act of 1933 (the "Securities Act") other than pursuant to Rule 24f-2 remained unsold at the beginning of the Fiscal Year.
3. 4,477,160 shares of common stock were registered under the Securities Act during the Fiscal Year other than pursuant to Rule 24f-2.

4. 10,401,944 shares of common stock were sold during the Fiscal Year.*
5. No shares of common stock were sold during the Fiscal Year in reliance upon registration pursuant to Rule 24f-2.

*Of this amount, 9,166,536 Class A shares were sold at an aggregate price of \$112,630,699 and 1,235,408 Class B shares were sold at an aggregate price of \$15,456,464. The aggregate sale price for all shares of common stock sold during the Fiscal Year was \$128,087,163
