**Explanation of Responses:**

1. Shares of restricted stock issued under the InFocus Corporation 1998 Stock Incentive Plan and subject to 4 year vesting schedule, with 25% vesting on the first anniversary of grant date and an additional 25% vesting on each of the second, third and fourth anniversaries of the grant date.
2. Option becomes exercisable as to 40% of the total shares one year from the date of grant, and as to an additional 2.5% each month thereafter.
3. Option becomes exercisable on February 3, 2007 as to up to 40% of the total shares if the Company achieves certain operating income goals, and as to up to an additional 2.6% of the total shares each month thereafter.

LIMITED POWER OF ATTORNEY FOR  
SECTION 16 REPORTING OBLIGATIONS

Know all by these presents, that the undersigned's hereby makes, constitutes and appoints Kyle Ranson and Candace L. Petersen, or any of them acting alone, the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:

(1) execute for and on behalf of the undersigned, in the undersigned's capacity as an officer and/or director of InFocus Corporation (the "Company"), Forms 3, 4, 5 and 13G in accordance with Section 16(a) of the Securities Exchange Act of 1934 and the rules thereunder;

(2) seek or obtain, as the undersigned's representative and on the undersigned's behalf, information on transactions in the Company's securities from any third party, including brokers, employee benefit plan administrators and trustees, and the undersigned hereby authorizes any such person to release any such information to the undersigned and approves and ratifies any such release of information; and
