HBK Master Fund L.P. holds an aggregate of 276,300 warrants, each warrant entitling the holder to purchase one share of the Issuer's common stock at a price of \$7.50 (the "Warrants"). Each Warrant will become exercisable upon the completion by the Issuer of a business combination, provided that the Issuer has an effective registration statement covering the shares of common stock issuable upon exercise of the Warrants and a current prospectus relating to them is available. The Warrants will expire on August 1, 2012, or earlier upon redemption. Because the Issuer has not completed a business combination as of the filing date of this Schedule 13G, the shares of common stock into which the Warrants are exercisable have not been included in the number of shares beneficially owned by any Reporting Person.
