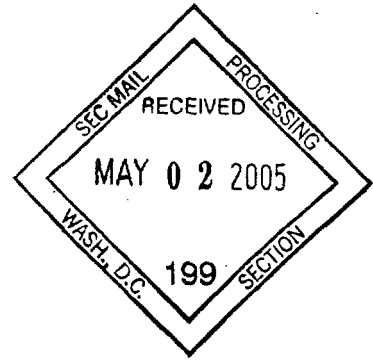

Bandai Co., Ltd. has its principal place of business at 1-4-8, Komagata, Taito-ku, Tokyo 111-8081, Japan; phone number: 81-3-3847-5003.




