Item 3. Applicable Statutory Provisions.

Item 3 is hereby amended by adding the following thereto:

"The issuance by Georgia of any evidences of indebtedness payable more than 12 months from the date of issuance must be approved by the Georgia Public Service Commission. Any such indebtedness, therefore, is exempt from Section 6(a) of the Act and rules thereunder pursuant to Rule 52, as amended."
