(NYSE: SZ) today announced that a lawsuit has been filed against the Company by the former President and Chief Executive Officer of its Pat & Oscar's division. The Company believes that the allegations, which include fraud and wrongful termination, are completely baseless and without merit. The Company plans to mount a full and vigorous defense in response to the allegations and is in the process of selecting its defense counsel.
