This Final Amendment relates to the Issuer Tender Offer Statement on Schedule TO (the "Statement") originally filed on November 22, 2002 by PW Health Sciences Fund, L.L.C. (the "Fund") in connection with an offer (the "Offer") by the Fund to purchase up to \$75,000,000 of interests in the Fund ("Interests") on the terms and subject to the conditions set forth in the Offer to Purchase and the related Letter of Transmittal.
