GRANITE REIT DECLARES MONTHLY DISTRIBUTION

May 16, 2013, Toronto, Ontario, Canada - Granite Real Estate Investment Trust (“Granite”) (TSX: GRT.UN / NYSE: GRP.U) announced today that its board of trustees has declared a distribution on Granite’ s stapled units of CDN\$0.175 per stapled unit. The distribution will be paid by Granite on June 14, 2013 to stapled unitholders of record at the close of trading on May 31, 2013. The stapled units will begin trading on an ex-dividend basis at the opening of trading on May 29, 2013.
