Wolters Kluwer €175 million Share Buy-back Program
Update November 26 - 30

Amsterdam (December 3, 2007) - Wolters Kluwer, a leading global information services and publishing company, today announces that in line with the launch of its €175 million share buy-back program on November 7, 2007, the company has repurchased 1,547,500 ordinary shares in the period November 26 until November 30, 2007.

The total number of shares repurchased under this program to date is 4,861,049 ordinary shares for a total consideration of €102.8 million.
