Sales for full year 2011 were approximately \$13.7M an increase of approximately 20% compared to \$11.4M sales during 2010. However, net loss for 2011 increased to approximately \$3.9M, compared to approximately \$3.5M loss of 2010, an increase of approximately 11%. The increase of net loss during 2011, is partly due to increase of 18% in our operating expenses, related mainly to sales –and- marketing expenses increase.
