The additional time required is principally the result of the combination of two factors, (i) the very recent consummation of a material agreement (which was disclosed in the Company's Current Report on Form 8-K filed with the Securities and Exchange Commission on April 22, 2005) and (ii) the need for the Company to incorporate into its Annual Report general financial reporting disclosure comments received by the Company from the Securities and Exchange Commission pursuant to a recent review of the Company's Annual Report on Form 10-K for the period ended January 31, 2004. As a result of the above two factors, the Company's normal procedures for preparing its Form 10-K were delayed by several weeks, and the Company has been unable to finalize its Form 10-K by the prescribed due date.
