(HD Brous") at the following prices: 5,000 shares at \$25 per share, 10,000 shares at \$24 13/16 per share, 10,000 shares at \$24 1/4 per share, 10,000 shares at \$24 7/16 per share, 15,000 shares at \$24 7/8 per share, 15,000 shares at \$24 1/2 per share, 15,000 shares at \$24 11/16 per share, 15,000 shares at \$24 per share, 20,000 shares at \$24 9/16 per share, 20,000 shares at \$24 3/8 per share, 25,000 shares at \$24 5/16 per share and 25,000 shares at \$24 1/8 per share. No commissions were paid to HD Brous in connection with such sale.

On July 26, 1995, the Selling Stockholder sold 20,000 shares of the Class A Common Stock. All 20,000 shares of Class A Common Stock were sold by the Selling Stockholder to HD Brous at the price of \$24 11/16 per share. No commissions were paid to HD Brous in connection with such sales.
