Item 8.01 - Other Events

As previously disclosed, APAC Customer Services, Inc. ("APAC"), a leader in global outsourced services and solutions, and One Equity Partners ("OEP"), the majority stockholder of NCO Group, Inc. (referred to as "us" or the "Company"), entered into a definitive merger agreement on July 6, 2011, under which an affiliate of OEP would acquire 100 percent of APAC, through an all-cash transaction with an aggregate equity value of approximately \$470 million. OEP has informed us that the transaction closed on October 14, 2011. OEP has further informed us that, OEP intends to continue to, as previously disclosed, seek to combine APAC with the Company to build market leadership in business process outsourcing and customer care solutions. The terms of any such combination have not been finalized and there can be no assurance that any such combination will be completed or if completed, the terms or timing of any such combination. We may have to borrow money, incur liabilities, or sell or issue stock as part of any combination and we may not be able to do so on terms favorable to us. Additional borrowings and liabilities may have a materially adverse effect on our liquidity and capital resources. Completing any such combination involves a number of risks, including diverting management's attention from our daily operations, the use of additional management, operational and financial resources, system conversions, and the inability to maintain key pre-combination relationships with customers, suppliers and employees. We might not be able to successfully integrate the combination into our business or operate the combined businesses profitably, and we may be subject to unanticipated problems and liabilities of APAC. On October 14, 2011, APAC issued a press release announcing the acquisition by OEP. A copy of the press release is attached hereto as Exhibit 99.1. Certain statements in this current report, including, without limitation, statements as to a potential combination with APAC, statements as to the Company's or management's beliefs, expectations or opinions, and all other statements in this press release, other than historical facts, are forward-looking statements, as such term is defined in the Securities Exchange Act of 1934, which are intended to be covered by the safe harbors created thereby.
