Gentlemen:

You have requested our opinion in connection with the registration by Edward D. Jones & Co. Daily Passport Cash Trust ("Trust") of an additional 700,440,688 Shares of Beneficial Interest ("Shares") pursuant to Post-effective Amendment No. 28 to the Trust's registration statement filed with the Securities and Exchange Commission under the Securities Act of 1933 (File No. 2-66437). The subject Post-effective Amendment will be filed pursuant to Paragraph (b) of Rule 485 and become effective pursuant to said Rule immediately upon filing.

As counsel we have participated in the organization of the Trust and its registration under the Investment Company Act. We have also participated in the preparation and filing of the Trust's amended registration statement under the Securities Act of 1933 referred to above. We have examined and are familiar with the provisions of the written Declaration of Trust dated January 9, 1980, ("Declaration of Trust"), the Bylaws of the Trust and such other documents and records deemed relevant. We have also reviewed questions of law and consulted with counsel thereon as deemed necessary or appropriate by us for the purposes of this opinion.

On the basis of the foregoing, it is our opinion that:

1. The Trust is duly organized and validly existing pursuant to the Declaration of Trust.

2. The Shares which are currently being registered by the Registration Statement referred to above may be legally and validly issued from time to time in accordance with the Declaration of Trust upon receipt of consideration sufficient to comply with the provisions of Article III, Section 3, of the Declaration of Trust and subject to compliance with the Securities Act of 1933, as amended, the Investment Company Act of 1940, as amended, and applicable state laws regulating the sale of securities. Such Shares, when so issued, will be fully paid and non-assessable.

3. Post-effective Amendment No. 28 does not contain disclosures which would render it ineligible to become effective pursuant to Paragraph (b) of Rule 485.

We hereby consent to the filing of this opinion as a part of the Trust's registration statement filed with the Securities and Exchange Commission under the Securities Act of 1933 and as a part of any application or registration statement filed under the securities laws of the States of the United States. We further consent to the reference to this opinion and the reference to us as counsel to the Trust in the prospectus, registration statements and applications.
