ITEM 6. OWNERSHIP OF MORE THAN 5% ON BEHALF OF ANOTHER PERSON:

The Prudential Insurance Company of America ("Prudential") may have direct or indirect voting and/or investment discretion over 2,036,300 shares of the Issuer's common stock. In addition, Prudential holds 64,880 rights/warrants to purchase the Issuer's common stock at a ratio of 1:1. These securities are held for the benefit of its clients by its separate accounts, externally managed accounts and registered investment companies. Prudential is reporting the combined holdings of these entities for the purpose of administrative convenience.

These shares were acquired in the ordinary course of business, and not with the purpose or effect of changing or influencing control of the Issuer. The filing of this statement should not be construed as an admission that Prudential is, for the purposes of Sections 13 or 16 of the Securities Exchange Act of 1934, the beneficial owner of these shares.
