This Amendment No. 1 ("Amendment No. 1") amends the Statement on Schedule 13G ("Initial Schedule 13G") filed with the Securities and Exchange Commission on February 1, 2000 by Heinz Rieger relating to the beneficial ownership of common shares of CFM Corporation, a corporation incorporated under the laws of Ontario. All responses to the items in the Initial Schedule 13G are hereby superseded by this Amendment No. 1.
