Know all by these presents, that the undersigned hereby makes, constitutes and appoints, N. David Bleisch, Lorna R. Simms, and Nancy A. Neal, or each of them acting singly, and with full power of substitution, as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:
