**HSBC HOLDINGS PLC**  
**THIRD INTERIM DIVIDEND FOR 2011**  
**ON ORDINARY SHARES**

The Directors of HSBC Holdings plc have declared a third interim dividend of US\$0.09 per ordinary share in respect of the year ending 31 December 2011 in accordance with their intention, as set out in the 2010 Annual Report and Accounts, to pay quarterly dividends on the ordinary shares in a pattern of three equal dividends with a variable fourth interim dividend. The ordinary shares will be quoted ex-dividend in London, Hong Kong, Paris and Bermuda on 23 November 2011. The American Depositary Shares will be quoted ex-dividend in New York on 22 November 2011. The dividend will be payable on 18 January 2012 to holders of record on 24 November 2011 on the Hong Kong Overseas Branch Register and 25 November 2011 on the Principal Register in the United Kingdom or the Bermuda Overseas Branch Register.

The third interim dividend will be payable on 18 January 2012 in cash in US dollars, sterling or Hong Kong dollars, or a combination of these currencies, at the forward exchange rates quoted by HSBC Bank plc in London at or about 11.00am on 9 January 2012, and with a scrip dividend alternative. Particulars of these arrangements will be mailed to holders of ordinary shares on or about 7 December 2011 and elections will be required to be made by 4 January 2012.

Any person who has acquired ordinary shares registered on the Hong Kong Overseas Branch Register but who has not lodged the share transfer with the Hong Kong Branch Registrar should do so before 4.00pm on 24 November 2011 in order to receive the dividend.

Any person who has acquired ordinary shares registered on the Principal Register in the United Kingdom but who has not lodged the share transfer with the Principal Registrar should do so before 4.00pm on 25 November 2011 in order to receive the dividend.

Any person who has acquired ordinary shares registered on the Bermuda Overseas Branch Register but who has not lodged the share transfer with the Bermuda Branch Registrar should do so before 4.00pm on 25 November 2011 in order to receive the dividend.

Removals of ordinary shares may not be made to or from the Hong Kong Overseas Branch Register on 25 November 2011. Accordingly any person who wishes to remove shares to the Hong Kong Overseas Branch Register must lodge the removal request with the Principal Registrar in the United Kingdom or the Bermuda Branch Registrar by 4.00pm on 23 November 2011. Any person who wishes to remove shares from the Hong Kong Overseas Branch Register must lodge the removal request with the Hong Kong Branch Registrar by 4.00pm on 24 November 2011.

Payment on Ordinary Shares held through Euroclear France

The dividend will be payable on ordinary shares held through Euroclear France, the settlement and central depository system for Euronext Paris, on 18 January 2012 to the holders of record on 25 November 2011. The dividend will be payable by Euroclear France in cash, in euros, at the forward exchange rate quoted by HSBC France at or about 12 noon on 9 January 2012, or as a scrip dividend. Particulars of these arrangements will be announced through Euronext Paris on 14 November and 30 November 2011.

Payment on American Depositary Shares

The dividend will be payable on American Depositary Shares, each of which represents five ordinary shares, on 18 January 2012 to holders of record on 25 November 2011. The dividend of US\$0.45 per American Depositary Share will be payable by the depository in cash in US dollars or as a scrip dividend of new American Depositary Shares. Particulars of these arrangements will be mailed to holders on or about 7 December 2011 and elections will be required to be made by 19 December 2011. Alternatively, the cash dividend may be invested in additional American Depositary Shares for participants in the dividend reinvestment plan operated by the depository.

In order to be eligible to receive the dividend, American Depositary Shares must be registered on the books of the depository by close of business on 25 November 2011.

**DIVIDEND ON 6.20% NON-CUMULATIVE US DOLLAR PREFERENCE SHARES, SERIES A ('SERIES A DOLLAR PREFERENCE SHARES')**

In 2005, 1,450,000 Series A Dollar Preference Shares were issued for a consideration of US\$1,000 each and Series A American Depositary Shares, each of which represents one-fortieth of a Series A Dollar Preference Share, were listed on the New York Stock Exchange.

A non-cumulative fixed-rate dividend of 6.20% per annum is payable quarterly on the Series A Dollar Preference Shares on 15 March, 15 June, 15 September and 15 December, for the quarter then ended, at the sole and absolute discretion of the Board of HSBC Holdings plc.

Accordingly, the Board of HSBC Holdings plc has declared a dividend for the quarter ending 15 December 2011. The dividend of US\$0.3875 per Series A American Depositary Share will be payable on 15 December 2011 to holders of record on 1 December 2011.

Any person who has acquired Series A American Depositary Shares but who has not lodged the transfer documentation with the depository should do so before 12 noon on Thursday, 1 December 2011 in order to receive the dividend.

## **INTERIM MANAGEMENT STATEMENT AND FINAL RESULTS**

As indicated in the announcement of the 2011 Interim Results, an interim management statement will be issued on 9 November 2011 and the results for the year to 31 December 2011 will be announced on Monday, 27 February 2012. The results announcement will be released at or after 4.15pm in Hong Kong (8.15am in London, 9.15am in Paris and 3.15am in New York), when the stock index futures and options markets in Hong Kong have closed. It is intended that any fourth interim dividend for 2011 that is announced on that date would be payable on 2 May 2012 to holders of record on the Hong Kong Overseas Branch Register on 15 March 2012 and on the Principal Register in the United Kingdom or on the Bermuda Overseas Branch Register on 16 March 2012. HSBC Holdings plc's ordinary shares would be quoted ex-dividend in London, Hong Kong, Paris and Bermuda on 14 March 2012. The American Depositary Shares would be quoted ex-dividend in New York on 14 March 2012.
