As of December 31, 2002, Apax Partners, Inc. ("Apax") may be deemed to be the beneficial owner of 1,482,970 shares of common stock (5.62%) owned by APA Excelsior V, L.P., a Delaware Limited Partnership, and 17,991 shares of common stock (0.07%) owned by Patricof Private Investment Club II, L.P., a Delaware Limited Partnership. Each of such entities is managed or advised by Apax and, as such, Apax may be deemed to have shared voting and dispositive power with the General Partners of each Partnership with respect to an aggregate of 1,500,961 shares of common stock.

This filing does not include 1,501,043 shares of common stock owned by funds

managed or advised by Apax Partners & Co. Ltd. and its affiliates.
