This Statement relates to the Shares (as defined herein) held for the accounts of each of West Face Long Term Opportunities Global Master L.P., a Cayman Islands limited partnership ("WFGM"), West Face Long Term Opportunities (USA) Limited Partnership, a Delaware limited partnership ("WFLP") and West Face Long Term Opportunities Master Fund L.P., a Cayman Islands limited partnership ("WFMF"). West Face serves as investment manager to each of WFGM, WFLP and WFMF. Mr. Boland is President and Chief Executive Officer of West Face. In such capacities, West Face and Mr. Boland may be deemed to have voting and dispositive power over the Shares held for the account of each of WFGM, WFLP and WFMF.

This amount consists of: (A) 4,423,612 Shares and 937,250 Shares obtainable upon conversion of the Issuer's 5.50% Senior Subordinated Convertible Notes due June 29, 2014 held for the account of WFGM; (B) 59,118 Shares and 30,250 Shares obtainable upon conversion of the Issuer's 5.50% Senior Subordinated Convertible Notes due June 29, 2014 held for the account of WFMF; and (C) 48,088 Shares and 24,500 Shares obtainable upon conversion of the Issuer's 5.50% Senior Subordinated Convertible Notes due June 29, 2014 held for the account of WFLP.

The number of Shares of which each of the Reporting Persons may be deemed to be the beneficial owner constitutes approximately 7.5% of the total number of Shares outstanding.
